

1.0 Scope

The Global GreenTag International (GGT) Product Health Declaration (PHD) has been designed to provide an additional level of service to the green product sector in facilitating an easier understanding of both the hazard and risks associated with any certified products, and is intended to indicate:

- Chemical hazards of both finished product and unique ingredients to a minimum level of 100ppm for final product throughout the product life cycle (including any VOC or other gaseous emissions);
- An assessment of exposure or risk associated with ingredient handling, product use, and disposal in relation to established mitigation and management processes;

It is not intended to assess:

- substances used or created during the manufacturing process unless they remain in the final product; or
- substances created after the product is delivered for end use (e.g., if the product unusually degrades, combusts or otherwise changes chemical composition).

GGT PHDs are only issued to products that have passed GGT Standards' certification requirements. The Level of Assessment (BronzeHEALTH, SilverHEALTH, GoldHEALTH or PlatinumHEALTH) of a PHD rating relates ONLY to a Human Health Toxicity Assessment and is declared separately and not equivalent to the overall Bronze, Silver Gold or Platinum GreenTag Certification Mark Tier Levels of LCARate.

1.2 Preparing a PHD

GGT PHDs are prepared in the format of a transparency document which utilizes Hazard Classifications from the UN Globally Harmonised System of Classification and Labelling of Chemicals (GHS). Hazard Classifications are then risk assessed with a focus on the In Use stage for an outcome of Certification. Assessments are undertaken by GGT Qualified Exemplar Global Lead Auditors and subsequently accepted for Certification by the GGT Program Director (also a Qualified Exemplar Global Lead Auditor) under the International Standard v4.0/4.1, Personal Products Standard v1.0/1.1, or Cleaning Products Standard v1.1/1.2 and above Program Rules.

1.3 External Peer Review

Every GGT PHD is independently peer-reviewed by an external Consultant Toxicologist and Member of the Australasian College of Toxicology & Risk Assessment.

2.0 Declaration of Ingredients

Where a manufacturer wishes recognition under a rating program that requires transparency of ingredients, such as LEED[®] v4.0 & v4.1, WELL[®] v1.0 & v2.0, Green Star[®], the following information is declared from the audit:

Colour	Ingredient Hazard Disclosure
Green	Level 4 The hazard level of this ingredient indicates that the ingredient has no toxic hazard statements with no identified health effects.
Yellow	Level 3 The hazard level of this ingredient indicates that the ingredient is mildly toxic and/or has short/medium term reversible health effects.
Orange	Level 2 The hazard level of this ingredient indicates that the ingredient is moderately toxic and/or with a moderate health effects.
Red	Level 1 The hazard level of this ingredient indicates that the ingredient is highly toxic with a potential for severe health effects.
Black	Level 0 The hazard level of this ingredient indicates that the ingredient is highly toxic with a potential for severe health effects and is banned from being detectable above trace amounts in the final product.
Grey	Grey Chemical Not able to be categorised due to lack of toxicity impact information.
Colour	Risk Assessment & In Use Health Assessment Outcome
Green	No Concerns The risk assessment outcomes for the hazard level and percentage of ingredient used in the product after risk assessment is considered highly unlikely and therefore without concerns.
Yellow	Human Health Comment The risk assessment outcome for the hazard level and percentage of ingredient used in the product is after risk assessment considered low with an unlikely potential risk.
Orange	Issue of Concern or Issue of Concern Minimised The risk assessment outcome for the hazard level and percentage of ingredient used in the product is after risk assessment considered low to high with a higher than unlikely potential for risk.
Red	Red Light Comment or Red Light Comment Minimised The risk assessment outcome for the hazard level and percentage of ingredient used in the product is after risk assessment considered low to extremely high with a moderate potential for risk.
Dark Red	Red Light Exclusion The risk assessment outcome for the hazard level and percentage of ingredient used in the product is after risk assessment considered medium to extremely high with a likely potential for risk.
Grey	Grey Chemical Not able to be categorised due to lack of toxicity impact information.
Black	Banned Ingredients Level 0 Hazard Level categorised chemicals such as Substances of Very High Concern in the International Standard v4.0/v4.1 and/or Petroleum, Parabens plus a wide range of additional compounds stipulated by the Personal Products Standard v1.0/1.1 and Cleaning Products Standard v1.1/1.2

If a tile is broken then perlite particles could be released. However, this even is unlikely and there are no carcinogenic, mutagenic or reproductive toxicity hazards identified for this substance. There are no Issues of Concern for the substance In-Use.</p> <p>Recycled Content: None Nanomaterials: Unknown</p>

Amylodextrin	9005-84-9	5-15%	None	OK				<p>There are no identified hazards during In-Use Phase. If a tile is broken then the Amylodextrin could release and form mild inhalation irritation. However, this is unlikely and the risk is low. There are no Issues of Concern for the substance In-Use.</p> <p>Recycled Content: None Nanomaterials: Unknown</p>
Material: Waste Newspaper								
Waste Newspaper	Filler	5-15%	None	OK				<p>The supplier has declared no hazards for this substance. If during the unlikely event the mineral tile is broken during use phase the newspaper is considered to have negligible risk as a toxic contaminant. There are No Issues of Concern for this substance In-Use.</p> <p>Recycled Content: 100% Post-Consumer Nanomaterials: Unknown</p>
Material: Vinyl Paint								
Vinyl Paint	Colour coat	5-15%	None	OK				<p>Formaldehyde is used in a concentration lower than 0.1% in the paint. The product has VOC testing which demonstrates Formaldehyde emissions are below 0.08 mg/m3. A regulatory limit adopted in the EU in 2023. There are no identified Issues of Concern.</p> <p>Recycled Content: None Nanomaterials: Unknown</p>

Material: Flame-Retardant Polymer Film

Flame-Retardant Polymer Film	Film	1-5%	None	OK				<p>The supplier has declared no hazards for this substance. If during the unlikely event the mineral tile is broken during use phase the fiberglass with flame-retardant film is considered to have moderate risk as a toxic contaminant, however amounts would unlikely release an amount with an Issue of Concern. There are No Issues of Concern identified for this substance In-Use.</p> <p>Recycled Content: None Nanomaterials: Unknown</p>
