

GLOBAL GREENTAG^{Cert™} STANDARDS LICENCE USER AGREEMENT

This Agreement is made on (Date) between

Global GreenTag International Pty Ltd, the system operator for Global GreenTag^{Cert™} Certification System, a limited liability company incorporated in QLD having its office at Level 38/71 Eagle Street, Brisbane City, Queensland 4000, Australia [ABN 44 600 051 554] and hereinafter called "GreenTag" and

WHEREAS:

- A. GreenTag is the licensed operator of the Global GreenTag^{Cert™} Standard and Registered Marks, which are now used by GreenTag in Australia, New Zealand, South Africa, Malaysia and beyond to provide the international green building industry with a set of performance requirements ('Standard') for the rating of environment, health and ethically preferred products with the aim of B2B and B2C communication products assessed under the Standard and subsequently used by Certified Licensees to advertise, market and promote the Certified products;
- B. GreenTag wishes to maintain version control over issued Standards;
- C. The User wishes to inform themselves in relation to the requirements of the GreenTag certification;
- D. GreenTag is willing to grant the User a free licence to use the Standard based on the terms below.

IT IS AGREED THAT:

1. Subject to this Agreement, the User is granted a licence to use the Standard at no cost.
2. The User may use the Standard to inform themselves about GreenTag Certification.
3. The User shall use Standard only for this purpose. Any other uses are required to be approved in writing by GreenTag.
4. To enable proper version control by GreenTag the User shall not provide copies of Global GreenTag^{Cert™} Standard to other party/ies but may make copies for internal company use. Using this information GreenTag will keep the user informed of any future updates.
5. The licence provided by this Agreement is not transferable to any other person and/or company.
 - a) GreenTag may suspend or revoke the licence to use the Global GreenTag^{Cert™} Standard in the event that GreenTag becomes aware of any instance of improper use of the GreenTag Standard;


